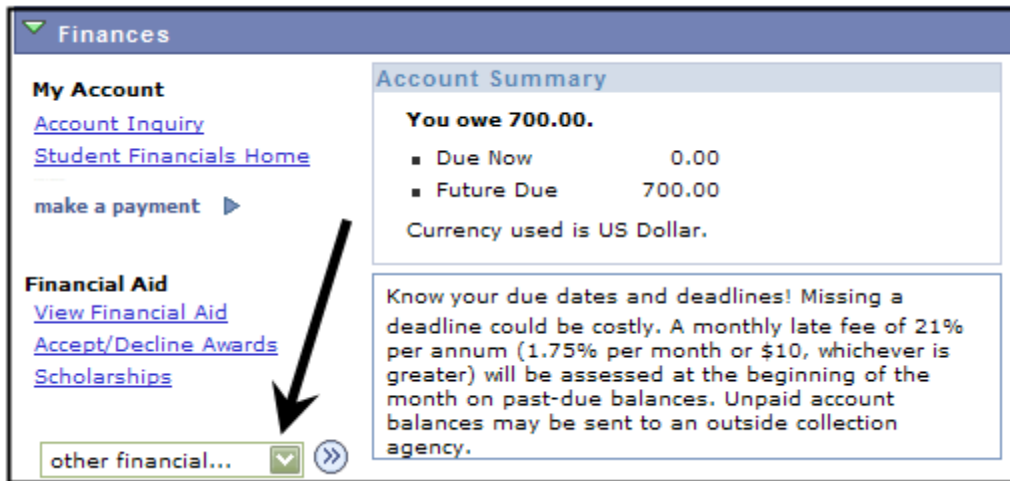



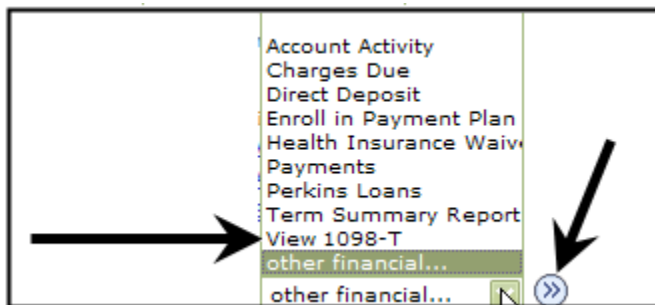
View your 1098t Tax Form

To view and print your 1098t tax form on-line, follow the steps below.

1. Sign into your Student Center on BroncoWeb and click on the **other financial** drop down box under the Finances Section



2. Select **View 1098-T** from the drop down box. Click on the blue arrows .



3. Click on the Grant Consent push button
